**RULES:**

- 1) Applications must be filled out completely.
- 2) Copy of vehicle registration required and proof of residence.
- 3) Payment due at time of issue.
- 4) You must notify the Village Clerk at (359-1258) immediately with any changes to the information on the application.
- 5) The Board of Trustees has determined that, based on availability, residents in a one-family home are entitled to two (2) permits per household in the lot nearest their residence. Multiple-family dwellings will be issued one (1) permit per unit/apartment in the lot nearest their residence to the extent such spaces are available. Additional parking permits may be obtained for other available lots in the Village (due to size and demand, requests for additional spaces in the Minehole, Rockpile, and Hudson Terrace lots will probably be filled in alternative lot locations).
- 6) You may only park in the area you have been assigned. If you have two cars assigned to two different areas, you may not switch them.
- 7) Stickers may not be transferred to another vehicle unless **authorized** by the Board of Trustees.
- 8) Parking permits are for overnight parking only (7pm to 8am.)
- 9) **Refunds/replacements only if original permit sticker is removed and returned.**

PARKING PERMITS MAY BE OBTAINED AT THE VILLAGE CLERK'S OFFICE ON  
MONDAY – FRIDAY FROM 9AM TO 3:30 PM OR BY MAIL.
